NEW LIFE LUTHERAN CHURCH is sponsoring a fall bazaar and BBQ. Booth spaces may be leased by exhibitors to display and sell hand-made crafts or limited non-competing manufactured items (*call for details*). We have over 80 booths available, some inside and some outside under Bazaar canopies.

The Church will reserve the rights of all food and beverage booths. Foods for sale will be Barbecued items, baked potatoes, baked goods and other food items.

There will be various children's games available on Saturday.

Drawings for door prizes will take place all three days at various times. All exhibitors are expected to donate an item from their booth for the drawings. Customers must be present to win.

Committee members, when available, will provide short break times for exhibitors, if desired.

The church will use the profit made from the bazaar for church improvements and donations to local charities.

Exhibitor fees are based on the amount of space rented. Outside 12' X 12' spaces on the grassy area are \$40.00 for three days and \$20.00 for one day. Outside 10' X 10' spaces under Bazaar canopies are \$50.00 for three days. Inside booths 7' X 7' and 8' X 8' are \$60.00 for three days. No inside booths are available for manufactured items. Space rental is based on the date the contract and payment is received in the church office, with preference given to repeat vendors.

Full refund will be issued with two weeks notice prior to bazaar opening. Half refund will be issued with one week notice prior to bazaar opening. No refunds will be issued the week prior to bazaar opening (this includes "no shows"). Any exceptions will be made at the Bazaar Committee's discretion. Refunds will be sent two weeks after the end of the bazaar.

Bazaar times are: Friday and Saturday 10:00 AM – 5:00 PM, Sunday 12:00 NOON – 3:00PM. On-site security Friday/Saturday night.

EXHIBITORS:

1. Provide picture of items to be sold (picture will be returned to you)
2. May rent more than one space
3. May begin setting up at 8:00 AM Friday and Saturday and 11:00 AM on Sunday
4. Must furnish display aids, tables, chairs
5. Shall be responsible for sales tax
6. Assume complete liability for occurrences within the space or with immediate customers
7. Agree to hold New Life Lutheran Church, the pastor and all members of the church harmless from any liabilities
8. Electricity will only be available for inside booths at an additional cost of \$5.00 per day
9. Agree to leave their space as tidy as when they arrived
10. No garage sale items or antiques
11. Limited non-competing manufactured items may be allowed (*call for details*)
12. Will not hold the church responsible for tables, tents, etc, left overnight inside or outside
13. Shall not drive on the lawn area of the church grounds
14. Must move vehicle to designated parking area
